

Vistek “Gimbal Giveaway Contest” - Official Rules & Regulations

Eligibility

The **VISTEK Gimbal Giveaway Contest** is open to Canadian residents who are active subscribers of Vistek's Weekly eNews. Unfortunately, this contest is not open to the residents of the province of Quebec. INDIVIDUALS MUST BE 18 YEARS OF AGE or older to be able to participate in the contest and claim any of the prizes. EMPLOYEES OF VISTEK and members of their respective families are ineligible to participate in the contest. EMPLOYEES OF ANY SPONSOR or agency involved with the contest and/or ProFusion Expo Virtual Connect are ineligible to participate in the contest, as are members of their respective families.

No purchase necessary to enter or win. A purchase will not increase your chances of winning.

How to Enter

New and existing Vistek eNews subscribers who have completed the contest entry form online and opened at least one Vistek eNews email during the calendar month, anytime between Friday, June 3, 2022 12:01 AM Eastern Standard Time (EST) and Friday, June, 24, 2022 11:59 PM Eastern Standard Time (EST) will be automatically entered. All entries are subject to the qualifications outlined in the eligibility criteria.

Limit of one (1) entry per person. A total of four (4) winners will be chosen at random to receive the prize. Winners will be notified within 30 business days of the contest closing date. **Odds of winning depend on the number of entries received.** In the event of a dispute over the identity of a potential winner, the potential winner may be required to provide identification sufficient to show that he/she is the person identified on the entry submission and is otherwise eligible to win.

Prizing

In this event, the prize will be awarded to an alternate entrant, who will be randomly selected from among the remaining eligible entries. Any alternate winner will have the same rights and obligations as the original winner.
