

# Vistek “Gear up for Winter” eNews Contest Official Rules & Regulations

## Eligibility

The **VISTEK “Gear up for Winter eNEWS SUBSCRIBE TO WIN CONTEST PROMOTION”** is open to Canadian residents who are currently subscribed to Vistek’s weekly eNews email only. Unfortunately, this contest is not open to the residents of the province of Quebec. INDIVIDUALS MUST BE 18 YEARS OF AGE or older to be able to participate in the contest and claim any of the prizes. EMPLOYEES OF VISTEK and members of their respective families are ineligible to participate in the contest. EMPLOYEES OF ANY SPONSOR or agency involved with the contest are ineligible to participate in the contest, as are members of their respective families.

Upon confirmation of your eNews subscription, you will be automatically entered in the Vistek **Gear Up for Winter Contest Promotion**, subject to the qualifications outlined in the eligibility criteria.

Limit of one (1) entry per person. A total of four (4) winners will be chosen at random to receive a one (1) of four (4) prize packages. Winners will be notified within 30 business days of the contest closing date. **Odds of winning depend on the number of entries received.** In the event of a dispute over the identity of a potential winner, the potential winner may be required to provide identification sufficient to show that he/she is the person identified on the entry submission and is otherwise eligible to win.
